**ORDER**

In pursuance of the Notification no. 46, dated 29<sup>th</sup> May, 2021 issued by Hon'ble Gauhati High Court, the order dated 15.05.2021 issued by the undersigned vide memo no. DJSV/COVID/2807-2818 is hereby extended up to 14.06.2021 with some minor changes due to the transfer of staffs within the establishment. 

6. It is pertinent to state that, under any circumstances, no person should use saliva while affixing court fee stamps on application(s)/petition(s) and/or any other document(s).


