The Presiding Officer of the respective Court shall prepare Cause List **as per Point No. 3 of the Notification No. 35, dated 1<sup>st</sup> May 2021 issued by Hon'ble Gauhati High Court** and such cause list shall be published by the respective Court for taking up matters to Virtual Courts atleast 3(three) days prior to actual date of hearing of the case.

All the Judicial Officers are directed to remain present and not to leave their respective station except in extreme urgency with due permission. The Judicial Officers who are not required to report for duty on any given day, will have to make themselves available for duty on call and they shall be deemed to be on duty during the entire period.

Advocates appearing at the Video-conferencing facility (Virtual Courts) **shall have to appear at the remote end of Virtual Court(s) as per the time slot(s) notified vide order dated 22-04-2021 of the undersigned** and, all concerned shall have to strictly follow all the Covid protocol(s) inside the court complex as well as inside the video conferencing facility at the remote end of the virtual court room.
