**Sub:** With reference to Hon'ble Supreme Court of India WP ( C ) No: 406/2013 Re- Inhuman conditions in 1382 prisons. And NALSA Letter No: L/10/2015-NALSA/914 dated 7<sup>th</sup> May, 2015.


The Jail Superintendent, District Jail informed that the District Jail in Sivasagar is not overcrowded. He pointed out, that Stretchers and Wheelchairs, Ambulance, Generator, Water filter and Running water are required for the District Jail, Sivasagar.

The living condition of the jail inmate's are also discussed, The Hon'ble District & Sessions Judge has suggested to explore the possibility of fulfilling the requirement of informed articles by requesting the ONGC Sivasagar to provide the same, under their CSR scheme. Jail Authority is advised to take up the matter with the Deputy Commissioner, Sivasagar.

During the discussion it is found that there are compoundable cases of the UTP's. It is resolved that the Secretary, DLSA shall organize Jail Adalat inside the jail, to reduce the pendency of such cases.

**RESOLUTION**

**Sub:** With reference to Hon'ble Gauhati High Court Notification No 52, dated 20<sup>th</sup> August, 2013 and Notification No. 24 dated 24<sup>th</sup> April, 2013.

Service and timely return of the processes are discussed. It is also resolved that the Superintendent of Police, Sivasagar and Superintendent of Police, Charaideo at Sonari, are requested to direct all the Police Stations to serve the process and return the same to the Court at least Two (2) days ahead of the date fixed. Hon'ble District & Sessions Judge has urged for proper service of processes, by showing example of improper service of summons in one case.


Superintendent of Police, Sivasagar has pointed out that non receipt of Medico Legal Reports caused delay in submitting CD's for bails / FF .

It is resolved that the Deputy Commissioner, Sivasagar and Deputy Commissioner, Charaideo at Sonari is requested to direct the Joint Director Health, Sivasagar to instruct all Medical officers in Sivasagar and Charaideo at Sonari to furnish injury report to the Investigating Officer on the same day or as early as possible.

The Superintendent of Police, Sivasagar assured to initiate an internal training programme, for the police to execute the processes and warrants more effectively.

**Sub:** Regarding Custody of valuables as well as, narcotic drugs and psychotropic substance.

The guidelines passed by Hon'ble Apex Court in UOI – vs- Mohan Lal are discussed. It is resolved that the Superintendent of Police, Sivasagar & Superintendent of Police, Charaideo at Sonari, shall pass necessary instruction to all O/C's of the concerned Police Stations to perform the role as mentioned U/S 52 (A) of the NDPS Act.


Superintendent of Police, Sivasagar has informed that the Government has formed the District Drugs Disposal Committee and requested the chair to pass necessary order in the disposed off cases for disposal of narcotic drugs and psychotropic substance as per provisions of Section 451 CrPC and 52 A (1) (2) NDPS Act,1985.

Legal problems in disposal of seized drugs in pending cases is discussed, and committee has requested the Hon'ble Sessions Judge,Sivasagar to do the needful according to Law.

So far, the disposal of Drug cases in disposed cases are concerned, the Superintendent of Police, Sivasagar informed the house that 04 (four) NDPS cases has already been disposed off, and the articles seized under these cases are ready for destruction matter is discussed.
