In pursuance of the order dated 05.08.2013, passed by the Hon'ble Gauhati High Court in WP(C)(TAKEN UP) No. 4299 of 2006, Hon'ble the Chief Justice has been pleased to direct that on the first Wednesday of every month, unless otherwise decided by the Registrar General of the Hon'ble Gauhati High Court or respective District & Sessions Judges, as the case may be.
