Item : To discuss the matter relating to the strengthening of monitoring mechanism for expeditious investigation and trial of cases.


Resolution: The District and Sessions Judge, Sivasagar, welcoming all the members of the committee, has initiated the discussions and has requested the Chief Judicial Magistrate, Sivasagar, present in the meeting, to arrange a sensitization and refreshment training for the newly appointed APPs of the Sibsagar and Nazira Bar Association. He has also asked the Chief Judicial Magistrate, Sivasagar to conduct the aforesaid training positively before the meeting of this Task Force.

Continuing the discussion, the District and Sessions Judge, Sivasagar, has asked the Addl. SP (Crime), Sivasagar present in the meeting, to ensure that the FIRs filed in various Police stations are placed before the CJM, Sivasagar on the same date of filing. He has also asked the Addl. SP (Crime), Sivasagar to ensure that if there is any overwriting in the date of filing of FIR then, proper note should be mentioned for such overwriting. He has further asked the Addl. SP (Crime), Sivasagar to direct the concerned I.O.s to ensure mentioning of proper note/ report for any delay in filing FIR.

The members present in the meeting, after a thorough discussion, have asked the Addl. SP (Crime), Sivasagar to sensitize the concerned I.O.s regarding the presence of the Bailors during every date of trial along with the Bailee, as per relevant provisions of law. In this connection, the Addl. District and Sessions Judge, FTC, Sivasagar, present in the meeting, has put forwarded a suggestion that the Bailor may report before the concerned I.O. or at the Police station on every date regarding the presence of the accused on the date fixed in the Court.

The meeting ends with vote of thanks from the chair.
