**Item** : To discuss the matter relating to the strengthening of monitoring mechanism for expeditious investigation and trial of cases.

**Resolution:** The District & Sessions Judge, Sivasagar, at the outset, has referred to a Case no. 06 (S-N)/2020 which is pending for statement of I.O. In this regard, the Hon'ble District & Sessions Judge, Sivasagar has requested the Addl. Superintendent of Police, representing SP, Sivasagar, present in the meeting to do the needful so that the aforementioned case can be disposed off at an early date possible. In this regard, the Addl. Superintendent of Police, has immediately called upon the concerned I.O. and directed him to be present before the Court on the next hearing date of the case.

The Addl. Superintendent of Police, Sivasagar, referring to recording of Statement under 161 Cr.P.C. has informed the members present in the meeting that necessary steps are being taken to collect identification documents along with permanent address so that the summons are served at a later stage on time facilitating swift disposal of cases.

The Secretary DLSA, Sivasagar present in the meeting, has mentioned about a Case No. PRC 745/19 where the case is pending due to statement of informant witness and in this regard, the District & Sessions Judge, Sivasagar has asked the Addl. Superintendent of Police, Sivasagar to look into the matter immediately in coordination with the Learned Public Prosecutor.

The Addl. Superintendent of Police, Sivasagar has asked the members of the Committee present in the meeting, whether the summons serving reports can be received through E-mail, which may perhaps facilitate swift service. In this regard, the District & Sessions Judge, Sivasagar has put forwarded a suggestion that the official E-mail ID i.e. [dsj-sivasagar@nic.in](mailto:dsj-sivasagar@nic.in) may be used for the purpose.

In the meeting discussions were also made regarding the status of the process pertaining to the final lists of cases to be withdrawn as per the Govt. ECF NO. 217405/2022/67 dated Dispur the 9<sup>th</sup> of December 2022 issued by the Judicial Department, Govt. of Assam.
