Item : To discuss the matter relating to the strengthening of monitoring mechanism for expeditious investigation and trial of cases.

Resolution: The Chief Judicial Magistrate, Sivasagar, at the outset, has referred to a Case no. PRC 745/19 which is pending for statement of P.W. Sri Barun Borgohain, S/o Bhuban Borgohain, No. 2 Garmariguri Ahom Gaon, P.S.-Merapani, Dist.-Golaghat . In this regard, the CJM, Sivasagar has requested the Superintendent of Police, to ensure the presence of the aforementioned P.W. so that the aforementioned case can be disposed off at an early date possible.

The Superintendent of Police, Sivasagar, referring to recording of Statement under 161 Cr.P.C. has informed the members present in the meeting that necessary steps are being taken to collect identification documents along with permanent address so that the summons are served at a later stage on time facilitating swift disposal of cases.


In the meeting discussions were also made regarding ensuring the presence of I.O.s through Video conferencing facility and also ensuring that the copy of summons issued to I.O.s may also be marked to the Superintendent of Police, Sivasagar for information and necessary action. In this regard, the District and Sessions Judge, Sivasagar has forwarded a suggestion that, a list of the cases which are pending for statement of I.O.s may be furnished to the Superintendent of Police, Sivasagar, for doing the needful in this regard from his end. He has also asked the Chief Judicial Magistrate, Sivasagar to prepare the aforementioned list under his supervision.


In the meeting discussions were also made regarding the status of the process pertaining to the final lists of cases to be withdrawn as per the Govt. ECF NO. 217405/2022/67 dated Dispur the 9th of December 2022 issued by the Judicial Department, Govt. of Assam. The members present in the meeting have asked ADC Sivasagar present in the meeting to make arrangement for wide publicity of the list of cases.

The meeting ends with vote of thanks from the chair.
