Item : To discuss the matter relating to the strengthening of monitoring mechanism for expeditious investigation and trial of cases.

The CJM, Sivasagar has requested the SP, Sivasagar to look into the matter. The SP, Sivasagar has informed the members of the Board that, necessary steps to ensure the presence of I.O.s have been initiated and Learned Courts may also inform the ADGP (CID), Assam in cases of repeated default of I.Os.


In the meeting discussions were also made regarding a point which has been raised by the Public Prosecutor present in the meeting of not receiving the delivery report of summons on time. In this regard, the District and Sessions Judge, Sivasagar has put forwarded a suggestion that, marking a copy of the summons to the Superintendent of Police, Sivasagar may resolve the issue.

In the meeting discussions were also made regarding wide publicity of the lists of cases to be withdrawn as per the Govt. ECF NO. 217405/2022/67 dated Dispur the 9th of December 2022 issued by the Judicial Department, Govt. of Assam. The members of the Board have been informed that, a Public notice has been issued by the Govt. of Assam on 17th of March, 2023 in this regard.

The District and Sessions Judge, Sivasagar has put forwarded a suggestion that a copy of the letters calling for Case Diaries may be marked to the SP, Sivasagar to ensure their timely production before the respective Courts. In this regard, the SP, Sivasagar has apprised the Board that PDF files of the Case Diaries have been maintained in the District of Sivasagar w.e.f. November, 2022.
