

**OFFICE OF THE CHIEF JUDICIAL MAGISTRATE : AT SIVASAGAR**

**ORDER**

In the interest of public service and smooth functioning of Court and office works, reshuffle of some staff of the establishment of Chief Judicial Magistrate, Sivasagar and withdrawal of execution cases are made as under:

1. Sri Ratul Gogoi, Copyist, O/o the Chief Judicial Magistrate, Sivasagar, who is presently working as bench assistant to the Court of Ld. Munsiff 1-cum-JMFC, Sivasagar, is withdrawn and assigned as bench assistant to the Court of Ld. JMFC, Sivasagar, Smti. P. Kalita.

5. As Sri Ankhuman Rajkhowa has availed earned leave w.e.f. 21-09-2022 to 01-10-2022, the works allotted to him shall be dealt with by Sri Joydeep Barooah, UDA, O/o the Chief Judicial Magistrate, Sivasagar, in addition to his own works till Ankhuman Rajkhowa resumes duty.
6. Sri Premadhar Deka, Process Server, O/o the Chief Judicial Magistrate, Sivasagar, is attached to the Court of Ld. JMFC, Sivasagar, Smti. P. Kalita.

All the execution cases under section 125 Cr.P.C., of the Court of the undersigned along with other subordinate Courts, which have been dealt with by Smti. Nayana Baruah, are hereby withdrawn to the respective Courts where the cases were tried. The dealing assistant is hereby directed to take necessary steps for handing over the cases to the respective Courts immediately.
