ORDER

Dated Sivasagar the 22nd of May, 2023

In the interest of public service and in pursuance of this Office Notification dated 9th May, 2023 issued vide Memo No. DJSV/STDR/F-84/2023/3052-3059 and, upon receiving of satisfactory Police verification report, **Sri Prodip Chutia**, S/o Late Bidyadhar Chutia, resident of Banmukh Dehingia Gaon, P.O.- Joyrapar, District- Sivasagar is hereby temporarily appointed as **Driver** in the establishment of the District and Sessions Judge, Sivasagar on contingency basis, in Pay of **Rs. 15,000/-** (Fifteen Thousand) only per month, initially for a period of **3 (three) months** from the date of his joining.

The post was originally sanctioned vide Govt. Letter No. JDJ.186/2019/5 dated 15.07.2019.

The aforementioned candidate is directed to **submit medical certificate** of fitness from Medical Officer of Government or by any Medical Officer in charge of a Civil Station at the time of joining.

The expenditure is debitable to the Head of Account "**2014-Admin. of Justice-105-Civil & Sessions Courts (Voted)-02-Wages.**"

The appointment is made on purely temporary basis and the incumbent cannot claim regular appointment on the basis of such temporary engagement and such engagement shall automatically terminate when regular appointment is made on creation of permanent post by Govt. of Assam. **The appointing authority reserves the right to terminate his service any time without assigning any reason thereof.**

The incumbent shall join in the respective post **within 15 (fifteen) days from issuance of this Order**, failing which his appointment shall stand cancelled.
