ORDER

Further, the above candidates, if presently employed in Central/State Government service, are directed to submit release order from the former employer at the time of joining. The services of the aforementioned candidates shall be governed by "The New Defined Contribution Pension Scheme" issued by the Government of Assam, Finance (Budget) Department vide office Memorandum No. BW.7/2008/pt./40, dated Dispur the 6th October, 2009. The selected candidates mentioned above shall have to submit an undertaking to that effect at the time of joining this establishment.

They will be **on probation for a period of 2 (two) years with effect from the date(s) of their joining. The District & Sessions Judge, Sivasagar reserves the right to cause dismissal from service any selected candidate during the period of probation without assigning any reason thereof.**

The expenditure will be made from the Head of Account "2014-Admin. of Justice-105-Civil & Sessions Courts (Voted)-01-Salaries."

The appointees shall join in the respective posts **within 15 days from receipt of this order.**
