### **GENERAL TERMS & CONDITIONS:**

- 1) The Sealed envelope containing quotation shall be marked as "**Quotation for scrapping of various official vehicles in the District Judiciary of Sivasagar**".
- 2) Quotations in sealed covers along with the copies of **Trade License, PAN Card and GST registration certificate, signed and sealed by authorized signatory**, should reach the undersigned on or before **31.08.2023** during office hours.
- 3) **The scrapping of the said vehicles will be governed by the following conditions:**
  - I) Scrapped value of the vehicles shall be counted separately for each vehicle, not through drawl of lot.
  - II) The vehicles will be sold on "as is where is basis".
  - III) The successful bidder will be required to deposit the amount by means of Cheque/ Demand draft in the Cost fund account to be notified later by this office.
  - IV) The scrapped vehicles will be removed by the successful bidder within 2 (two) working days of depositing the amount, at their own expenses.
  - V) The successful bidder will also be responsible for getting registration certificate of the vehicles and/or any other documents as required by the RTO, in his name at his own cost expeditiously. This office shall not be responsible for any lapse on his part in this regard.
  - VI) The successful bidder shall also submit "Certificate of Deposit" in this office within 30 (Thirty) days from lifting the vehicle.
  - VII) The bid amount shall be excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.
  - VIII) The undersigned reserves the right to accept/reject any/ all of the quotation without assigning any reason thereof.
