1. District Judge – Chairman
2. Chief Judicial Magistrate – Member
3. One Member to be chosen by the District Judge and the Chief Judicial Magistrate.

The District Judge will immediately inform the undersigned the name of the third member of the Cell.

The District Judges shall submit to the Registry monthly report regarding functioning of the Vigilance Cells and the action taken in respect of the complaints received by such Cells.

A copy of this Notification should be displayed on the Notice Board of all Courts.
